### DIRECTIONS FOR USE

ROOT-MAXX is for use on all plant material. It is optimized for use with fertigation systems but may also be used in foliar applications. ROOT-MAXX may be added to any FERTI-MAXX fertility product, most other fertilizers, and most agricultural chemicals after conducting a jar test for compatibility. Always treat a small test area with any experimental blends to determine potential phytotoxicity before making general applications. Use year round, effective in cool and hot weather.

### APPLICATION RATES / INTERVALS

FERTIGATION SYSTEMS: Add 1 quart of ROOT-MAXX for every 10,000 square feet of landscape.

FOLIAR APPLICATIONS: Mix 1 ounce per gallon of water and apply evenly. Repeat until desired results are achieved. Do not exceed the 2 ounces per gallon maximum rate.
