### DIRECTIONS FOR USE

FERTI-MAXX PHOS-FREE is a fertilizer product for use on all plant material. It is optimized for use with fertigation systems but may also be used in foliar applications. FERTI-MAXX PHOS-FREE may be added to any FERTI-MAXX fertility product, most other fertilizers, and most agricultural chemicals after conducting a jar test for compatibility. Always treat a small test area with any experimental blends to determine potential phytotoxicity before making general applications. Do NOT mix with fertilizers containing Calcium in spray tanks as precipitation and clogging may occur.

### APPLICATION RATES / INTERVALS

FERTIGATION SYSTEMS: Use 1 pound per every 2,000 square feet. Refill or apply every 4 to 6 weeks. Amount can be increased or decreased depending on desired results and plant needs.

HAND APPLICATIONS: Mix 1/2 Tablespoons per gallon of water and apply by spray or watering can for outdoor plants. Mix 1/4 teaspoon per gallon for indoor plants. Apply every 1 to 2 weeks.

WARNING- Product contains boron and molybdenum. Use of the fertilizing material on any crops other than those recommended may result in serious injury to the crop(s).
